2010 - 2012 CONTINUING EDUCATION REQUIREMENTS

- Each licensee needs to complete 18 hours of Continuing Education by October 31, 2012
- Each year licensees need 2 hours of Continuing Education credit that involves law, rules and court cases regarding real estate. The remaining 12 hours can be obtained at any time during the 3 year cycle.
- Topic numbers and course names must be different from the other courses that licensees have taken during the 3 year cycle.
- For Continuing Education purposes, a year runs from January 1st through December 31st except for the last (third) year which runs from January 1st through October 31st (the date all licenses expire.)
